MINUTES OF THE MEETING OF WEST DOWN PARISH COUNCIL HELD AT WEST DOWN PARISH HALL ON 7th MARCH 2018

The Chair opened the meeting at 7.30pm with apologies for absence received from CCIIr A Davis and PCSO P Grantham.

3753. <u>Police Report</u>. The Police Newsletter showed 0 crimes for the month in the West Down area.

3754. <u>Public Speaking</u>. The Clerk informed all, that due to ill health he will be unable to carry out his full role of Parish Clerk for the up and coming months. Throughout this period it was unanimously agreed that he will be assisted by Rebecca Pine.

3755. <u>Minutes of the Last Meeting.</u> The Minutes of the meeting held on 7th February were signed and approved following 2 manual amendments.

3756. Matters Arising.

a. 3746a. Chair has visited the Pearl Dean site and spoken to site manager about concerns of a resident.

b. 3747b. Cllr Oades agreed to check if the 3 stiles have been cleared on FP5 in Cheglinch.

3757. <u>CCIIrs Report</u>. CCIIr A. Davis sent a written report which has been placed in the float file.

3758. DCIIr Report, DCIIr M Wilkinson reported the following:

a. Proposal to discontinue Parish Grants and DCIIr Grants etc have been overturned, so may now continue in the future.

b. West Down sign tiles have come off as a result of cold weather.

c. Two Enforcement Officers will be leaving soon so the enforcement department will not be at full strength until replacements have been trained up.

d. Plastic Free North Devon – A meeting has been held concerning single use plastic with initiatives such as 'We are Plastic Free' notices for hotels etc.

e. Trimstone Lay By. Correspondence has been received from Mr P Milton of Trimstone Manor outlining his concerns about the lay by and picnic site which has been purchased by a private owner. The responsibility for Fly Tipping should be down to the new owner. DCllr Wilkinson will try and find out who the new owner is.
