MINUTES OF THE MEETING OF WEST DOWN PARISH COUNCIL HELD AT WEST DOWN PARISH HALL ON 3rd OCTOBER 2018.

The Chairman opened the meeting at 7:30pm with apologies from Cllr K Oades and PCSO P Grantham.

3842. Police Report. The following crimes were reported during the last month:
