# MINUTES OF THE MEETING OF WEST DOWN PARISH COUNCIL HELD AT WEST DOWN PARISH HALL ON 7<sup>th</sup> NOVEMBER 2018.

Present: Cllr C King (Chairman), Cllrs S Ayre, R Drew, F Hookway, K Oades, S Squire and R Watts.

The Chairman opened the meeting at 7:30pm with apologies from CCIIr A Davis, DCIIr M Wilkinson and PCSO P Grantham

- 3854. Police Report. The following crime was reported during the last month:
  - a. Criminal damage x 1.
- 3855. Minutes of the Last Meeting. The Minutes of the last meeting were approved and signed.

## 3856. Matters Arising.

- a. 3844a. Still awaiting response regarding alleged planning infringements at the 'Pearl Dean' site.
- b. 3844c. DCllr Wilkinson to check regarding signage on the old picnic site.
- c. 3844d. Having investigated cost the decision has been approved to purchase a 35ltr metal bin at the price of £223.79 to replace the bin in the wooden bus shelter. Cllrs Oades and Drew have offered to install the bin.
- d. 3845c. CCllr Davies reported that although there was minor damage to the bridge, nothing will be done by DCC. Cllr Watts offered to fix the damage.
- e. 3845d. The flooding at Willingcott has cleared.
- f. 3852d. A poppy wreath has been purchased which Cllr King has agreed to lay on behalf of the Parish Council on Remembrance Sunday.

## 3857. CCllr Report. CCllr Davis sent a written report on the following:

- a. Food waste Some households are still putting food waste in black bins instead of using food caddies provided.
- b. Recycling Devon is doing well for recycling but householders are encouraged to recycle more.
- c. Road closures Work is continuing to cause road closures on the A361 Link Road by Tiverton, the A399 by Combe Martin and the B3230 near Blakewell Fisheries.
- d. Parish Salt Mr John Hookway has offered to store snow salt bags at the farm, provided they are waterproof.

#### 3858. Devon Air Ambulance.

a. Cllr Watts previously questioned why it has been requested that planning permission be re-applied for in 3 years, (in regards of the planning application for the air ambulance landing light). DCllr Wilkinson has sent a letter to Planning to query this decision which also applies to the light at Woolacombe. The Chair has also drafted a letter to Des Brailey which was approved by the Parish Council.

b. It was confirmed that the West Down Village Green Field Committee would be responsible for the air ambulance landing pad, supported by the Parish Council when appropriate.
