## WEST DOWN PARISH COUNCIL MINUTES

West Down Parish Hall. (Main Hall) on Wednesday 7th July 2021 at 7.30pm.

Present: Cllrs. S Ayre (Chair), M Reeves (Vice-Chair) R Drew, S Squire, K Oades, M O'Halloran, and D Cllr M Wilkinson.

Apologies/Approvals. C Cllr A Davis. (AONB meeting). Cllr T Verney is unable to attend until September due to work commitments. Apology accepted.

4393. Public Speaking/Question Time. None.

# 4394. Beavers - Presentation.

The Beaver Trust gave a short presentation explaining how Beavers can benefit the surrounding land by helping to create natural flood plains and marsh land for the benefit of other species. A Q&A followed. The hope of the Beaver Trust is to get landowners with waterways through their land, to allow Beavers to be introduced, initially on upland areas. It is planned to give a larger insight into their work at a public meeting to be held in the near future.

### 4395. Police Report.

The Braunton Neighbourhood Police Newsletter July 2021 has been circulated to the councillors and posted on the village website.

The main points are:

Dogs die in hot cars. Never leave a dog unattended in a car. How to prevent moorland and countryside fires and what to do if you spot one. Don't invite thieves into your home this summer, shut all windows and doors when out. Ask a neighbour to look after your home when away.

Crime figures for Mortehoe/Woolacombe & West Down, includes Mullacott and Bittadon. Violence with Injury x 1, Violence without Injury x 1, Theft x 5, Public Order offences x 2, Vehicle Offences x 2, Other Offences x 1, Burglary - Dwelling x 1, Criminal Damage x 1, Possession of Drugs x 1 and Non-notifiable Offences x 1.

Only 2 of these recorded crimes were in the West Down Parish.

# 4396. Approve of Minutes from the last meeting.

The June Minutes were unanimously approved and signed.

#### 4397. Matters Arising.

4373 - Recycling Chapel Court - no further forward.

4373 - Climate and Environment Grant - the criteria for this grant have been changed. It is now usable for areas such as Orchards and Wild Flower meadows.

4392e. The Village Sign is back in place. Thanks, given to Cllr M Reeves and assistant.

#### 4398. Report from County Councillor.

The A399 will be closed between Mockham Down (near the Bratton Turning) and Aller Cross Monday to Thursday inclusive the next two weeks, so if anyone needs to get to the link road on these dates between 8am and 8pm they will need to find an alternative route.

### 4399. Report from District Councillor.

The Rural Housing Alliance have produced an information guide called, Affordable Rural Housing: A practical guide for parish councils that is available online. Following on from the CLT presentation it could be an interesting read. It looks at problems with the new planning applications but is more directed to towns and cities.

Cllr Wilkinson mentioned two other grant funds that were worth looking at, both via the AONB North Devon:

- 1) The Sustainable Development Fund has £26K available for expressions of interest for grants of up to £4K
- 2) The Nature & Climate Challenge Fund, with grants of up to £4K. Info and help can be sought from Laura Carolan of AONB on 01271 388628 or email laura.carolan@devon.gov.uk

North Devon Leisure Centre and the Watersports Centre in Ilfracombe are on track for completion on time.

D Cllr Grant - Website. £400-450.

Cllr M Reeves has acquired quotes for a website that vary from £475 to £745 these figures include training and setup. A quote from one potential supplier is less to set up but slightly higher ongoing costs, against a quote from a company with more experience and lower ongoing costs. It is recommended that the Councillors look at other Parish Websites in the area, Fremington, Berrynarbor and Mortehoe in particular, and give their opinions at the next meeting.

#### 4400. Acorn Developments.

A copy of the Acorn/NDC agreement signed 23/06/2021 has been received. This is in place of the original S106 agreement upon which viability did not allow them to deliver. The revised states that monies to be paid are, to the Community £67,838. Education £34,084.23 and School Transport £4,577.77. The total monies payable are £106,500. The community money is payable to NDC within 20 working days from the agreement date (21/7) and then within 10 working days to West Down Parish Council (01/8). The Education & School Transport money is to be paid to Devon CC before the occupation of the 13<sup>th</sup> dwelling. A letter to be sent to K Miles about the importance and urgency of the Education contribution.

NDC Complaint department, Jo Teasdale is looking into the case this week. A conclusion is expected by the 9<sup>th</sup> July. A letter will be sent prior to Friday 9<sup>th</sup> to say we accept but are not happy with it, is proposed by Cllr. M O'Halloran, 2<sup>nd</sup> Cllr M Reeves. Unanimous approval.

The Head of Planning is now Maria Bailey (not Head of Place).

#### 4401. CLT (Community Land Trust).

The Ilfracombe presentation was directed more at the public. The money side seems less that land owners would expect. Affordable planning permission is easier on land offered. There is a need to establish what our need would be. Information received indicates there are 15 local people on the housing needs list. NDC confirmed. Cllr Oades mentioned that he believed a survey was done when Lower Broad Park was planned. Large support would be needed from the community and available land sought.
